Meeting Notes

Secretary Andy Ruff was out of town for business travel. Notes below are from Debbie Pirkl, reference Emails from Debbie dated: 1/26/2014 18:00 and 2/19/2014 08:56.

1. Meeting was called to order at 19:38 by President Debbie Pirkl.
2. Devotions: skipped devotions due to special session called.
3. New Business:
 - 3.1. 2014 Budget
 - 3.2. Discussion of 58,500 budget deficit
 - 3.3. With addition of Saturday service, we would like to think plate offering will be increased to 8,500.00
 - 3.4. Suggestions to help with shortfall: Possibility of an April fundraiser; presented by Dean Eisfelder (building a bridge from Lego's) a visual identifier for congregation to see how close we are to completing our bridge by purchasing LEGO bricks to make this happen.
 - 3.5. Pastor Cassie suggested charging more rent for our building, as well as implementing someone to help out Jan Perkins; she is here way too often for opening up gym and scheduling these events. This could help with revenue.
 - 3.6. Executive council approached Pastor Cassie about the possibility of reducing her hours to 80% of her time. – Launch as early as Feb 1, 2014
 - 3.6.1. Would like to get all jobs in line before launch of the Bridge on Saturday nights.
 - 3.6.2. Hopefully this decrease in hours will be a short term fix and by 2015 we can be back to 2 full time pastors.
 - 3.6.3. If there is a noticeable need, Pastor Cassie will be reinstated to full time and then budget deficit will be revisited.
4. Total cost savings to bottom line will be 21,500
 - 4.1. Will present budget to congregation at annual meeting with a 37,000 [deficit? atr]
 - 4.2. Motion to approve 6 approved / 1 opposed
5. Old Business:
 - 5.1. Up for discussion Constitutional amendment about length of presidents role
